WHAT THE LAW SAYS . . .

Provision from the UP EDUCATIONAL INSTITUTIONS (REGULATION OF RAGGING) REGULATIONS, 2009

Ragging means the act intended to promote by action, disposition, power of senior students, teachers, staffs or students, to humiliate, abuse or threaten the dignity of students who are admitted to any educational institution or to force on any student or students any act or course of action which is not intended to benefit the student or students.

Prohibition of ragging

1. No person shall engage in ragging or attempt to do so in any educational institution.

2. No person shall engage in ragging or attempt to do so in any educational institution for a term which is longer than the term of the institution.

Responsibility of the students

1. Every student admitted to any educational institution shall be bound to observe the provisions of these regulations and to report any act of ragging to the authorities of the institution.

2. No student shall engage in ragging or attempt to do so in any educational institution.

3. No student shall engage in ragging or attempt to do so in any educational institution for a term which is longer than the term of the institution.

Responsibility of the staff

1. Every staff member of any educational institution shall be bound to observe the provisions of these regulations and to report any act of ragging to the authorities of the institution.

2. No staff member shall engage in ragging or attempt to do so in any educational institution.

3. No staff member shall engage in ragging or attempt to do so in any educational institution for a term which is longer than the term of the institution.
